Workers Comp Update:

- There are three employees out on light duty, one of which will be cleared in June. Another employee, Josh McHugh, is out on workers comp and might have surgery before he can return to work on light duty. Tom Moran is also on short-term light duty.

Hiring Update:

- The five new hires will graduate from the Academy on June 7th, 2019.
- Southern Marin Fire has hired one extra firefighter to replace Tony Vitalie when he retires on May 17, 2019.
- Fire Prevention has two new hires, both of which are able to use their skills to disperse the workload more evenly throughout their department. Fire Prevention

plans to hire two more inspectors, one for vegetation and one as a fulltime inspector. The job descriptions have been posted in the newspaper, on social media and the District's website.

- Deputy Fire Chief Peterson informed the Directors that the process for accepting applicants for the new Measure U subcommittee has begun and there will be applicants to approve at the upcoming Board Meeting.

Firefighter Reserve:

- The cost is greater than the benefit at this time since there are five new hires coming on after they graduate from the Academy. The District will not pursue creating a reserve; however, they are in support of the idea.
